Management Discussion of the Performance of the CWB Onyx Conservative Solution

Results of Operations

In the first six months of 2021 (the “period”), the CWB Onyx Conservative Solution’s (the “Fund’s”) net assets increased by \$1,075,810 to \$8,562,621. This reflects an increase of \$93,192 from investment performance, net contributions of \$1,035,634 and distributions to unitholders of \$53,016.

Series A units of the Fund returned 0.93% over the period versus the Fund’s internal benchmark (the “Fund Benchmark”), which returned 0.70%. The Fund Benchmark is a combination of FTSE Canada Universe Bond Index¹,

¹ The FTSE Canada Universe Bond Index is designed to be a broad measure of the Canadian investment-grade fixed income market.

S&P/TSX Composite Total Return (“TR”) Index², S&P 500 TR Index \$CAD³ and the MSCI All Country World Index (ACWI) ex-USA \$CAD⁴. The Fund’s general market index benchmarks, the FTSE Canada Universe Bond Index and the S&P/TSX Composite TR Index (the “Broad-Based Benchmarks”), returned -3.46% and 17.28%, respectively, over the period. Unlike the Fund Benchmark and the Broad-Based Benchmarks, the Fund’s return is calculated after the deduction of fees and expenses. Returns for Series O unitholders of the Fund may vary, largely due to differences in fees and expenses.

Despite significant headwinds, the global economy and financial markets continued to recover in the first half of 2021. Significant government and central bank stimulus helped to support current economic activity. Vaccination programs against COVID-19 that had just begun at the end of 2020 gathered pace, which helped to build confidence in a gradual economic recovery. By the end of the period, vaccination rates were high enough for many global economies to begin relaxing COVID-19 driven restrictions on activities such as travelling, social distancing and in-door restaurant dining. The U.S. led the way on the recovery with two consecutive quarters of greater than 6% growth.

After strong returns in 2020, fixed income investments posted negative returns during the period. As confidence in the economic recovery gained traction, investors traded out of the relative safety of fixed income for riskier, higher-returning assets such as equities. The Canadian bond benchmark (FTSE Canada Universe Bond Index) returned -3.46% in the first half of 2021. The fixed income portion of the portfolio provided higher returns than the benchmark.

Global equity markets performed well during the period. Equity indices in developed markets such as Canada, Europe and the U.S. largely generated double-digit percentage returns in local currency. Although emerging markets tended to lag behind developed markets, returns were also broadly positive. The performance of the equity market appeared to somewhat mirror COVID-19 vaccination trends with developed markets achieving higher rates of vaccination in a quicker time frame than emerging markets. Economically sensitive segments of the market (such as energy and financials) performed well to start the year while less sensitive sectors (such as information technology) provided stronger returns towards the end of the period. The equity holdings within the Fund are weighted toward more economically sensitive areas resulting in the equity holdings negatively impacting performance of the Fund relative to the benchmark during the period.

The Fund started 2021 with approximately 4% overweight in equities and a 4% underweight in fixed income, which reflected the manager’s belief that government and central bank stimulus would be sufficient to bridge the global economy through the period of COVID-19 restrictions and into a prolonged period of economic growth. With interest rates at extremely low levels, the risk of higher rates in a recovering economy made equities an attractive investment compared to fixed income. As the period progressed, equities continued to outperform fixed income

leading to approximately a 6% equity overweight at the end of the period. The Funds equity overweight was a positive contributor to returns relative to the Funds benchmark.

Recent Developments

Global growth in early 2021 accelerated further due to a number of positive factors including vaccination campaigns, additional fiscal stimulus and reduced health measures all leading to improved economic activity. This was evidenced by strong global economic indicators and corporate profits with earnings beating expectations at a record pace. Despite this strength, investors appear to be focused on issues like increasing inflation and whether growth may be peaking. The consensus view of economists is that the near term inflation uptick will likely prove to be somewhat temporary. We agree with the consensus view and anticipate strong economic growth through the remainder of 2021, which supports a continued overweight in equities and an emphasis on corporate bonds.

Related Party Transactions

CWB Wealth Management Ltd (“CWB WM” or “we”) serves as trustee, manager, portfolio advisor, and principal distributor of the Fund. The Fund pays CWB WM a management fee as compensation for its services. Refer to the section titled ‘Management Fees’ for a summary of fees paid to CWB WM.

The Fund invests in units of the CWB Onyx Portfolio Series Funds. These Funds are related and connected issuers of the Fund, as CWB WM serves as trustee, principal portfolio advisor, and manager for the CWB Onyx Portfolio Series Funds.

The IRC of the Fund has approved standing instructions permitting investments in the CWB Portfolio Series Funds, and other mutual Funds managed by CWB WM or its affiliates (the “Fund of Fund Investing”). The standing instructions require that the Fund of Fund Investing be conducted in accordance with CWB WM policy and that CWB WM will advise the IRC of a material breach of the standing instructions. CWB WM policy requires that an investment decision in respect of Fund of Fund Investing (i) is made free from any influence by an entity related to CWB WM and without taking into account any consideration relevant to an entity related to CWB WM; (ii) represents the business judgment of the portfolio manager/sub-advisor uninfluenced by considerations other than the best interests of the Fund; (iii) complies with CWB WM policy; and (iv) achieves a fair and reasonable result for the Fund.

CWB WM entered into a participating dealer agreement (the “Dealer Agreement”) with Canadian Western Financial Ltd. (“CWF”), an affiliate of CWB WM. Pursuant to the Dealer Agreement, CWB WM pays CWF a monthly trailing commission equal to 1/12th of 0.75% of the net asset value attributable to units of the Fund held by CWF clients. This trailing commission is paid directly by CWB WM and does not increase the management fee paid to CWB WM by the Fund.

⁴ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a Fund's portfolio turnover rate in a year, the greater the trading costs payable by the Fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a Fund.

Management Fees

The Fund pays CWB WM an annual management fee of 1.30% of the net asset value of Series A units of the Fund. The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund's management fees were used by CWB WM to pay for the cost of managing the investment portfolio, providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sales of investment portfolio, providing other services, and compensating CWB WM for acting as the trustee of the Fund. CWB WM also used the management fee to Fund trailing commissions and any other compensation to CWF whose clients invest in the Fund. A further breakdown of the management fee is not available for the interim period.

Series O management fee is negotiated and paid directly by each investor. Series O management fee is not to exceed the Series A management and advisory fee of the Fund.

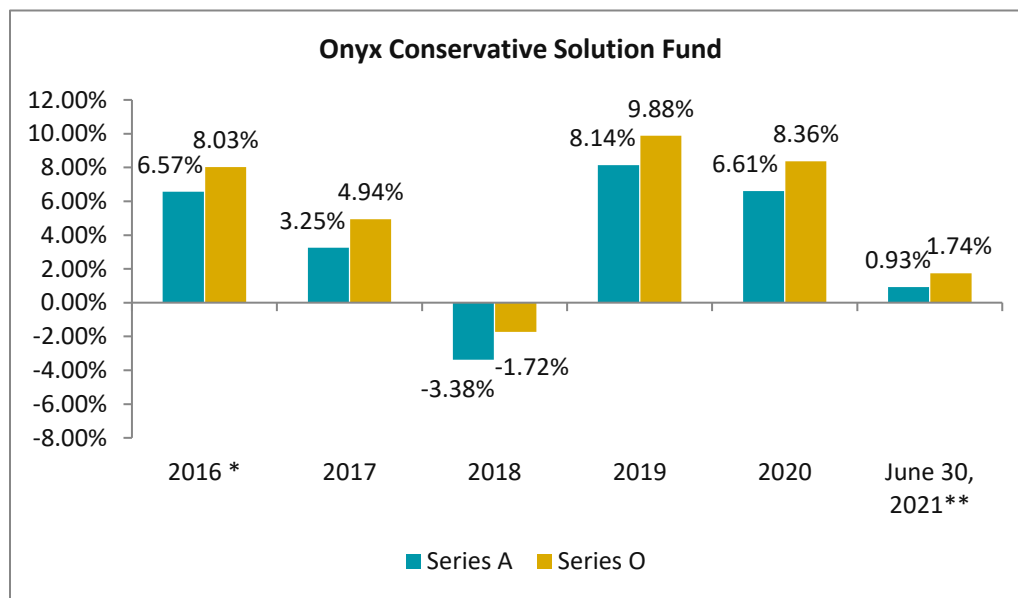
Past Performance
