Management Discussion of the Performance of the CWB Onyx Global Equity Fund

Results of Operations

In the first six months of 2021 (the “period”), the CWB Onyx Global Equity Fund (the “Fund’s”) net assets increased by \$14,908,406 to \$93,906,155. This reflects an increase of \$6,829,213 from investment performance, net contributions of \$8,977,119 and distributions to unitholders of \$897,926.

Series A units of the Fund returned 7.26% over the period versus the Fund’s internal benchmark (the “Fund Benchmark”), which returned 9.27%. The Fund Benchmark is a combination of the S&P 500 Composite Total

Return (“TR”) Index \$CAD¹ and the MSCI All Country World Index (ACWI) ex-USA TR \$CAD² (the “Broad-Based Benchmarks”), which returned 17.28% and 6.36%, respectively over the period. Unlike the Fund Benchmark and the Broad-Based Benchmarks, the Fund’s return is calculated after the deduction of fees and expenses. Returns for Series O unitholders of the Fund may vary, largely due to differences in fees and expenses.

Global equity markets performed well during the period. Equity indices in developed markets such as Europe and the U.S. largely generated percentage returns in the double-digits in local currency. Although emerging markets tended to lag, results were also strongly in positive territory. The equity market trends somewhat mirrored COVID-19 vaccination trends with developed markets achieving higher rates of vaccination in a quicker time frame than emerging markets.

The U.S. portion of the Fund benefited from an over-allocation of financials and consumer discretionary, with these sectors outperforming on the back of an expectation for a strong economic recovery. From a sector perspective, energy was the best sector during the first half of the year (H1) and our slight underweight was a drag on performance. Our portfolio benefited from not owning Amazon and Tesla, both underperforming in the period.

Our International holdings were positive contributors to relative performance during the period although there has been volatility as market participants balance a recovering economy with fears of new COVID-19 variants and possible inflation. Positive contributions have come from Europe and from a sector point of view, consumer discretionary was a standout. Emerging markets, and China in particular, have been a drag on performance as the Chinese governments increased regulation on the Internet space has hurt stocks like Alibaba and Tencent.

Recent Developments

Global growth accelerated further in early 2021 due to a number of positive factors including vaccination campaigns, additional fiscal stimulus and reduced health measures all leading to improved economic activity. This was evidenced by strong global economic indicators and corporate profits. Despite this strength, investors have recently been focused on issues such as increasing inflation and whether growth may be peaking. The economic consensus view is that the near term inflation uptick will likely prove to be somewhat temporary, and that strong economic growth will continue through the remainder of 2021.

The Fund, remains positioned for a growing economy and the global economic re-opening which is largely underway. With vaccination efforts around the world continuing, economic activity is returning quickly, which should lead to strong performance from economically sensitive sectors. In the near-term, we expect the summer months could be more volatile than usual, as re-opening from a pandemic is something that market participants have not experienced before. There are key issues (inflation, COVID-19 variants, etc.) that require monitoring, but the big picture of strong, above-trend global growth to the end of 2021 should be supportive of continued strong performance in equity markets.

Related Party Transactions

CWB Wealth Management Ltd. (“CWB WM” or “we”) serves as trustee, manager, portfolio advisor, and principal distributor of the Fund. The Fund pays CWB WM a management fee as compensation for its services. Refer to the section titled ‘Management Fees’ for a summary of fees paid to CWB WM.

CWB McLean & Partners Wealth Management Ltd. (“CWB M&P”) acts as a sub-advisor to the Fund. CWB M&P is a subsidiary of CWB WM. As a sub-advisor, CWB M&P is paid a fee for their services. This fee is paid by the Manager directly and does not increase the management fees paid by the Fund.

The CWB Onyx Managed Solution Funds, comprised of the CWB Onyx Conservative Solution, the CWB Onyx Balanced Solution and the CWB Onyx Growth Solution, invests in Series O units of the Fund. As at June 30 2021, 1.65% of the Series O units of the Fund are held by the CWB Onyx Conservative Solution, 14.98% of the Series O units of the Fund are held by the CWB Onyx Balanced Solution, and 12.15% of the Series O units of the Fund are held by the CWB Onyx Growth Solution.

CWB WM is party to a participating dealer agreement (the “Dealer Agreement”) with Canadian Western Financial Ltd. (“CWF”), a subsidiary of CWB WM. Pursuant to the Dealer Agreement, CWB WM pays CWF a monthly trailing commission equal to 1/12th of 1.00% of the net asset value attributable to units of the Fund held by CWF clients. This trailing commission is paid directly by CWB WM and does not increase the management fee paid to CWB WM by the Fund.

⁴ The Fund’s portfolio turnover rate indicates how actively the Fund’s portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund’s portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Fund pays CWB WM an annual management fee of 1.85% of the net asset value of Series A units of the Fund.

The management fee for each applicable series is calculated and accrued daily as a percentage of its NAV. The Fund’s management fees were used by CWB WM to pay for the cost of managing the investment portfolio, providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sales of investment portfolio, providing other services, and compensating CWB WM for acting as the trustee of the Fund. CWB WM also used the management fee to Fund trailing commissions and any other compensation to CWF whose clients invest in the Fund. A further breakdown of the management fee is not available for the interim period.

Series O management fee is negotiated and paid directly by each investor. Series O management fee is not to exceed the Series A management and advisory fee of the Fund.

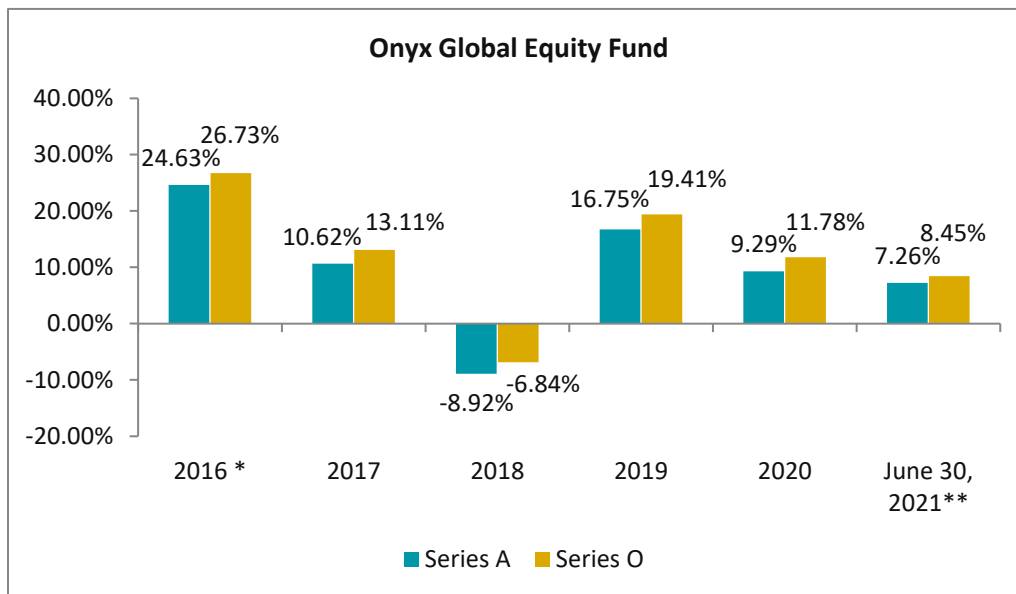
Past Performance
